Commissioner Huizenga moved and Commissioner Barringer seconded to approve Change Order #1 on Airport Road Reconstruction Project for a reduction of \$28,763.50. Unanimous approval.

Ian Paul, Twila Hight, and Matt Elberson provided an overview of the proposed Dwelling Rental Licensing and Inspection Program. The program would be established through a new Ordinance and managed through a registration/licensing and inspection process. Informational meetings will be held and public feedback will be considered at a public hearing. The ordinance will then come back to the Commission for consideration.
