Optional side pot for largest walleye will be **\$10 per team**. Please include this with your registration if participating.

No more than 8 walleye will be permitted in the boat: 2 of the 8 walleye can be over 20" and the other 6 walleye between 15"- 20". Fishing to be held on Lake Sharp from the Oahe Dam Power house south. Weigh-in will be held at Downs Marina, starting at 3:00pm. Late arrivals will be DQ'D. Early weigh-ins will start at 1pm if needed.
